MINIMIZING EXPOSURE

- Number of exposures
 - Caseload- minimize to urgent and emergent only
- Type of exposure
 - Maximize distancing, minimize contact
- Exposure risk
 - Minimize contact with shedding people
 - Minimize contact with contaminated surfaces
- Protection
 - PPE
 - Disinfection

COVID-19 in Pets

- No confirmed cases of 'reverse zoonosis' of COVID-19
- No evidence pet animals are a source of the virus
- A person with COVID-19 can "shed" the virus onto their pet, who could then infect a healthy individual who pets them. All animals with fur, from dogs and cats, even ferrets, hamsters, and guinea pigs, can potentially play a role.



COVID-19 in Pets

- In Hong Kong, 3 pet animals have tested PCR positive
 - Dog #1 17-year-old Pomeranian, Weak Positive, Also antibody positive, Died of undetermined cause
 - Dog #2 2-year-old GSD, Positive twice then Negative
 - Cat #1 DSH, oral cavity, nasal, and rectal samples tested positive, may or may not have had clinical signs of the disease
 - All cases are pets from households of COVID-19 positive humans
 In Hong Kong, all mammalian pets from COVID-19+ households are advised to be put in quarantine facilities.
- In the USA, no cats or dogs have tested PCR positive
 - IDEXX labs, >4000 samples, no false positives reported



COVID-19 in Animals

- COVID-19 replicates poorly in dogs, but efficiently in ferrets and cats
- All inoculated cats and ferrets got infected and seroconverted, but only 2 inoculated dogs became seropositive
- COVID-19 transmits in cats via respiratory droplets
- Pigs, chickens, and ducks were found not susceptible to the virus



"Essential services"

- As of now, <u>CT</u> has included veterinary medicine without a narrowed definition. NY and other states in the region have limited veterinary medicine to emergency only, with variable restrictions.
- AVMA to practices in areas with COVID cases:
 - Consider limited in-person patient care to acutely ill animals and/or emergencies
 - Beware that state gathering limits could apply to your clinic (waiting room more likely than staff – currently limit is 5 pple in CT)
 - Reschedule elective procedures and all nonessential appointments to limit staff and public exposure
 - Be strategic with PPE use
 - Use emergency teletriage and telehealth where possible



VETERINARY LEGISLATIVE CHANGES

Telemedicine

- AVMA and <u>FDA</u> definitions of valid VCPR includes requirement that the veterinarian has "recently seen" the animal or facility in question.
 - <u>AAVSB</u> (American Association of Veterinary State Boards) has less rigorous recommendations, leaving more room for telehealth in vet med
 - Unlike other states, CT does not seem to have specific/separate language re: VCPR – refers to AVMA site guidelines
- <u>FDA statement regarding relaxation of VCPR/COVID</u> is very narrow only pertains to extra label drug use and veterinary feed directive drugs.



VETERINARY LEGISLATIVE CHANGES

DEA

- Certain requirements pertaining to refills, ordering, dispensing, and paper vs oral prescribing have been temporarily relaxed to minimize in-person interactions for prescribing controlled substances.
- Full details are listed <u>here.</u>
- Policy as pertains to physicians summarized in this decision tree is effective 3/31/2020. (Telehealth comments likely do not apply to veterinarians.)



- Families First Coronavirus Response Act
 - Extended FMLA, additional paid time off benefits
 - Document, document, document
- HIPAA, discrimination and privacy regarding medical information
- Employee status and benefits
 - Underemployment (furlough)
 - Unemployment (lay off)
 - Work sharing (sharedworkct.com, NY Dept of Labor)
 - Notify your healthcare provider!



Financial

- Minimizing cash burn is key
- Experts project 50% decrease receipts in GP for 12-16 weeks.
- Multiple options are available under the Families First Coronavirus Response Act (FFCRA) and the Coronavirus Aid, Relief and Economic Security (CARES) Act
 - Payment Protection Program (PPP) Loans
 - Shared Work Program (10-60% decrease work)
 - Refundable Tax Credits for Paid Leave Obligations
 - Employee Retention Credit (50% reduction in receipts. Not with PPP)
 - Delay of Payment of Employer Payroll Taxes
 - Economic Injury Disaster Loans & Emergency Economic Injury Grants
 - Small Business Debt Relief Program

PPP

- For eligible employers, the Paycheck Protection Program could prove very attractive.
- Provides 8 weeks of loan funding for certain payroll and benefit expenses, utilities, rent and/or mortgage interest.
- If a certain employment levels are maintained, the loan may be eligible for conversion to a grant.



- Some options under FFCRA and CARES are mutually exclusive. Consult financial advisor before making any decisions.
- The Paycheck Protection Program (PPP) is expected to conclude disbursements by June 30, 2020. Don't wait to apply if interested.
- Lenders administering the PPP program are being inundated and will likely prioritize their own customers. Talk to your current bank or lender first to see if they are participating.
- Banks are warning of potential scams. Consult an attorney or CPA before making any commitments.
